Pursuant to a sale and purchase agreement dated 21 December 2020 entered into between Kinetix Systems Limited, an indirect wholly-owned subsidiary of the Company, as purchaser and Dalian Luminary Technology Inc. as vendor, the Company issued convertible bonds in an aggregate principal amount of HK\$48,000,000 with nil interest per annum will mature on the fifth anniversary from the date of issue on 1 February 2021. As at the date of this monthly return, the outstanding convertible bonds amounted to HK\$48,000,000 which may be converted into 160,000,000 Shares at the initial conversion price of HK\$0.3 (subject to adjustments). Details are disclosed in the announcements of the Company dated 21 December 2020, 6 January 2021, 20 January 2021 and 1 February 2021.
