Pursuant to a sale and purchase agreement dated 21 December 2020 entered into between Kinetix Systems Limited, an indirect wholly-owned subsidiary of the Company, as purchaser and Dalian Luminary Technology Inc. as vendor, the Company issued convertible bonds in an aggregate principal amount of HK\$48,000,000 with nil interest per annum will mature on the fifth anniversary from the date of issue on 1 February 2021.

On the announcement dated 10 May 2021, the convertible bonds at the principal amount of HK\$48,000,000 were fully converted at the initial conversion price of HK\$0.3 (subject to adjustments) into 160,000,000 Shares where (i) 60,000,000 shares are allotted and issued to Mr. Lam Sze Chun Jackson; (ii) 50,000,000 shares are allotted and issued to Goldlink Hong Kong Investment Limited; and (iii) 50,000,000 shares are allotted and issued to Rich Trend Hong Kong Investment Limited. As at the date of this monthly return, all the outstanding convertible bonds have been fully converted.

Details are disclosed in the announcements of the Company dated 21 December 2020, 6 January 2021, 20 January 2021, 1 February 2021 and 10 May 2021.
